I, on my own behalf and on behalf of my heirs and assigns, do hereby now and forever fully and finally release, remise, acquit and discharge radio sta on WIVK, Cumulus Media, Inc., its subsidiary companies and affiliates, officers, directors, employees and agents (collec vely, "Cumulus") of and from any and all rights, claims, debts, damages, demands, aco ns, liabili es, responsibili es, causes of ac on, covenants, suits and judgments, of any kind or nature whatsoever, whether known or unknown, developed or undeveloped, an cipated or unan cipated, discoverable or undiscoverable, which I have or might have or might claim to have against Cumulus, arising out of or in any way related to or associated in any way with regard to my par cipa on in the Event, or any injury, damage or loss of any nature related to or arising out of or in connec on therewith.

I hereby grant Cumulus the right to use my name, likeness, voice, biographical and other informa on for adver sing, promo onal, and related purposes in connec on with the ac vi es or promo on of the Event.

The par es agree that the terms of this Agreement shall be binding upon and inure to the benefit of the par es and their respec ve heirs, successors and assigns. Notwithstanding anything herein to the contrary, this Agreement shall be fully enforceable by either party in any ac on at law or in equity, and nothing contained herein shall preclude or be construed to preclude any ac on in law or in equity by either party against the other to enforce the provisions of this Agreement. This Agreement shall be governed by and enforced and interpreted in accordance with the law of the State in which the Event is conducted. If any provision or part of a provision of this Agreement shall be determined to be void or unenforceable by a court of competent jurisdic on, the remainder of this Agreement shall remain valid and enforceable by any party.
